On August 19th the ANC2F Committee on Crime and Public Safety (CCPS), along with community volunteers, conducted a survey of Single Member Districts 2F02, 2F04 and 2F05. We recorded a number of observations during the survey, the majority of which will require city agency action. Enclosed you will find a summary of the approximately 17 incidents of graffiti in the area and 6 incidents of abandoned bike frames/locks. Please coordinate with the appropriate city agency to ensure the graffiti and abandoned property are removed as promptly as possible.
