COMMUNITY FORUM

Chairman Reed noted a quorum was present, called the meeting to order at 7:00 p.m. and directed the Executive Director file a copy of the notice of the meeting with the minutes.

Commissioner Announcements

Chairman Reed announced that, shortly before the public meeting, the ANC had welcomed a delegation of community leaders from several Latin American countries at the behest of the U.S. Department of State. The ANC presented a discussion as to the history, purpose and operations of the ANC system in Washington. Members of the delegation were present for the meeting and were introduced.

Lt. Michael Smith Retirement from MPD. Please join the Logan Circle community and LCCA as we celebrate Lt. Michael A. Smith's retirement and honor his many years of service to the Logan Circle community and to the District of Columbia. For the few of you who don't know him (or have his cell phone on your speed dial), Mike is a 27-year veteran of the Metropolitan Police Department. He is virtually unparalleled as a tireless, effective and dedicated officer. As former Chief Ramsey said of him in testimony before the D.C. City Council, "If I had 10 more like him, I wouldn't need to increase the size of the MPD."

We in this community have seen him in action. He makes every ANC and LCCA meeting, including the committee meetings of the Crime and Safety Committee of our ANC. He is the first man at any community action event, like clearing graffiti, handing out flyers, or policing the streets. He is a dogged police officer, constantly making arrests and responding without regard to whether he is on or off duty when there are emergencies in his PSA, and often uses his personal funds to get needed equipment that MPD's budget will not cover.

While we are distressed to see Lt. Smith leave, we look forward to honoring him and celebrating the next phase of his life on November 8, 2008 8:00 PM at the Ronald Reagan Building Ballroom. The cost is \$35.00 per person and a government ID is required. Cost has been kept to a minimum so as many people as possible can join us in the celebration. We are also soliciting donations in excess of \$35/person to help defray costs and to provide Mike with a nice gift and honorarium befitting his years of service and dedication to the community. All money raised for this event will go towards the actual costs for the event and towards the gift/honorarium, so we encourage you to be generous. Please join the Logan Circle Community Association for its October meeting and candidates forum on October 15, 2008 from 7-10 p.m. at the Washington Plaza Hotel. LCCA will host candidates for At-Large and Ward council positions, as well as ANC2F candidates. Commissioner Dyer noted that crime statistics in the Logan Circle neighborhood have decreased overall in the past year, and violent crime has decreased 44 %. However, car crime is still a problem in Logan Circle. See www.crimemap.DC.gov for more information about crime in the Logan Circle area.

PSA 307 Report – Lt. Mike Smith

In likely his last report, Lt. Smith reiterated that robberies and violent crimes are down sharply; but that thief from auto is up 267% from this time last year. He urged residents not to keep valuables in their cars.

Ward 2 Councilman Jack Evans

Jack Evans addressed the meeting. He stated that despite budget problems in neighboring jurisdictions, the City's finances are sound; however in light of the growing national financial crisis and likely turndown, there will be some cut backs or delays in secondary services. The District's \$300 million in new initiatives are expected to be continued, but at a prudent pace and with quarter by quarter reassessment of the financial climate. If a shortfall develops due to the worsening economy, the Mayor is planning not to cut primary service jobs, but to either raise taxes or not fill secondary vacant positions. Councilman Evans also stated that Logan Circle currently has the greatest amount of development in the City, and all its major projects appear to be sound.

Christopher Ziemann reported that the final report on the 14th Street Transportation and Streetscape study can be viewed at www.14thstreetstudy.com. He states that the plan is still flexible and projects a 5 to 10-year window for its implementation.

15th Street- DDOT received a lot of request for bike lanes and two-way traffic. DDOT is still reviewing alternatives.

Studio Theater- Pole Banners- Public Space Renewal

Upon motion by **Dyer**, seconded by **Reed**, and after further discussion, it was:

RESOLVED, That the ANC2F advise DDOT to grant the pending application of The Studio Theater for a public space permit to hang five season and five show banners on designated lamp posts (located on 14th Street, NW between P and Q Streets and P Street, NW between Kingman Place and 15th Street) in the Logan Circle neighborhood from November 1, 2008 through November 30, 2009, with the condition that The Studio Theater routinely inspect and maintain the banners in good condition.

Community Development Committee Matters

Logan Circle Neighborhood Investment Fund

Emily Yates, Ward 2 Planner, presented the Logan Circle Neighborhood Investment Fund (NIF) to the Community Development Committee. The NIF is an annual, non-lapsing, revolving fund to finance economic development and neighborhood revitalization in 12 target

neighborhoods. The NIF is funded through an annual appropriation of 17 percent of a personal property tax, not to exceed \$10 million.

One of the requirements of the enabling legislation, the Neighborhood Investment Act of 2004, is for the Mayor to develop NIF Investment Plans for each of the target area using input from community stakeholders including the Advisory Neighborhood Commissioners, residents, business owners, faith community, not for profit organizations, among other groups. The purpose of the Investment Plan is to set community priorities for how the NIF funds should be utilized in the target area over a five year period.

Even though the official comment period is closed, the DC Office of Planning will still accept public comments regarding the Logan Circle NIF. www.planning.dc.gov

4 Logan Circle, NW

Architect Patrick Brown requested ANC support for the project at 4 Logan Circle, NW, which has pending before DDOT an application for curb cut and variance for the driveway off Kingman Place, behind the projects. The application and variance is necessitated by the 60 ft requirement between a driveway and an intersection. The driveway will be 29 feet from the intersection of P Street, NW and Kingman Street, NW.

Previously, the Applicant appeared before ANC 2F's Community Development Committee and the full ANC to discuss the concept, design and massing; BZA variances; and HPRB matters of the same project, all of which resulted in favorable support from the ANC. .

The DDOT hearing for public space is schedule for October 23, 2008. Recent concern about retaining wall being in public space has been corrected. A total net gain of two parking spots will be achieved (lose one public space and gain three private spaces). **Reed** in whose SMD the project is located indicated that the residents most affected by the request have asked that the ANC act favorably on the additional request.

Upon motion by **Dyer**, seconded by **Benardo**, and after further discussion, it was:

RESOLVED, That the ANC2F send a letter to advise DDOT to grant the waiver in support of the Public Space Application and variance from the 60 ft provision.

Horizon House- housing facility 12th and Massachusetts Ave, NW

Commissioner Cole brought to the attention of the Commission the deplorable, unsafe and unhealthy state of Horizon House, a City owned elderly housing facility within his SMD. Upon motion by **Dyer**, seconded by **Cole**, and after further discussion, it was:

RESOLVED, That ANC2 formally request the District of Columbia Housing Authority to provide information as to conditions, budget and management of Horizon House, 12th and Massachusetts Ave., NW, so as to enable this Commission to exercise its statutory functions under §1-309 of the District of Columbia Code, with the view of improving conditions for the residents of that facility, and it is,

FURTHER RESOLVED, That Commission Dustin Cole, ANC 2F-05, be and is hereby authorized and directed to report to this Commission at its November 2008 public meeting, or at a public meeting as soon thereafter as feasible on recommendations for actions in the public interest regarding this facility, it being anticipated that a representative of DCHA will be requested to appear before this

Commission at the same time.
