#### **COMMUNITY FORUM**

**Charles Reed**, *chairman pro tem*, noted a quorum was present, called the meeting to order at 7:00 p.m. and directed the Executive Director file a copy of the notice of the meeting with the minutes.

#### **Election and Installation of Officers 2009**

Elections: **Charles Reed** turned the meeting over to **Cyndie Cot**a to handle the annual elections. She asked for nominations for Chair. **Mike Benardo** nominated **Charles Reed**. **Brian Vargas** seconded. No other nominations were made. Nominations were closed, and a vote was called. Charles Reed was elected **Chairman**, to serve until his statutory term expires or until his successor is duly qualified to serve. **VOTE:** (5-0) unanimous

Reed then assumed the chair. He opened nominations for Vice Chair. Brian Vargas nominated Mike Benardo. Reed seconded. No other nominations were made. Nominations were closed, and a vote was called. Mike Bernardo was elected Vice Chairman, to serve until his statutory term expires or until his successor is duly qualified to serve. VOTE: (5-0) unanimous.

Nominations for Secretary were opened. **Reed** nominated **Brian Vargas**. **Benardo** seconded. No other nominations were made. Nominations were closed, and a vote was called. **Brian Vargas** was elected Secretary, to serve until his statutory term expires or until his successor is duly qualified to serve. **VOTE:** (5-0) unanimous.

**Reed** opened nominations for Treasurer. **Benardo** nominated **Dustin Cole**. **Reed** seconded. No other nominations were made. Nominations were closed, and a vote was called. **Dustin Cole** was elected Secretary, to serve until his statutory term expires or until his successor is duly qualified to serve. **VOTE:** (5-0) unanimous.

**Reed** asked for nominations to chair the CDC (Community Development Committee). **Matt Raymond** nominated **Mike Benardo**. **Brian Vargas** seconded. No other nominations were made. Nominations were closed, and a vote was called. **Mike Benardo** was elected chairman of the CDC, to serve until his term expires or until his successor is duly qualified to serve. **VOTE:** (5-0) unanimous.

**Reed** asked for nominations for the Crime and Public Safety Committee, and he nominated **Matt Raymond**. **Benardo** seconded. Nominations were closed, and a vote was called. **Matt Raymond** was elected chairman of the Crime and Public Safety Committee, to serve until his term expires or until his successor is duly qualified to serve. **VOTE:** (5-0) unanimous.

**Reed** noted that it is important to the functioning of the Commission that it be advised of legislative and regulations matters that may affect ANC2F and its constituents. Upon motion by **Reed**, second by **Bernardo**, and after further discussion, it was:

**RESOLVED,** That an ad hoc committee to be called the Legislative Committee be, and is hereby, established to serve at the pleasure of the Commission, to advise the Commission on all matters involving legislation before the City Council or regulations of the agencies of the District of Columbia government which may affect constituents of ANC 2F or the work of ANC 2F, including matters which arise in the Council or the agencies, or which the Legislative Committee proposes be initiated by the Commission in the sense of advising the City Council or the appropriate agency, as the case may be, to initiate the same; and it is,

**FURTHER RESOLVED,** That Monica Schneider be and is hereby elected to be the chair of such Committee.

# PSA 307 Report – Lt. Hauser

A homicide occurred at 11<sup>th</sup> and Q Streets in December and the MPD believed this crime was a robbery and was not a hate crime. An arrest was made in connection with a robbery at 1300 block of Corcoran after the perpetrators crashed a stolen car in the 3<sup>rd</sup> Street tunnel. The Bike Rack, 1400 block of Q Street had been experiencing a rash of break-ins where high-end bikes have been stolen. A juvenile arrest, related to this break-in, has been made. Lt. Hauser pointed out that one issue that is driving up the crime rate in the Logan Circle area is out-of-state auto thief and thief from autos that involve electronic equipment like computers, cell phones and navigational systems. The prostitution issue at Massachusetts Avenue and L Street is still a problem. If crime continues to be down, some officers will be reassigned but the same number of officers will be on the streets. Gun registrations are still being accepted in the District. Commissioner **Reed** pointed out that **Lt. ## **Community Announcements**

The Washington Metropolitan Area Transit Authority (WMATA), in partnership with the District Department of Transportation (DDOT), wants to enhance bus service through District neighborhoods. Currently, many District of Columbia neighborhoods lack efficient surface transit circulation to support mobility and accessibility; neighborhood-to-neighborhood connectivity; and District-wide economic development goals. The District of Columbia Neighborhood Circulation Study (Study) builds from previous studies to comprehensively develop surface transit connections between District neighborhoods, activity centers, and major transit corridors. DDOT has already begun to improve some service with the assistance of WMATA by adding new routes, expanding existing routes, and establishing the DC Circulator in 2005. However, there is still more to be done. The focus of this study is to:

- 1. Identify current deficiencies in neighborhood transit connectivity;
- 2. Improve local bus services to enhance neighborhood circulation as well as connectivity between neighborhoods and District activity centers;
- 3. Identify new neighborhood services which will enhance circulation and connectivity; and,

4. Complement the long-range transit system as planned in the DC Transit Alternatives Analysis.
