#### **Commissioner Announcements**

# **PSA 307 Report - Officer Michelle Caron**

Officer Michelle Caron introduced Sergeant Allen and Captain. Snyder. As to crime statistics, robbery increased 200% but this only means this there were three robberies in February as compared to one in February 2008. One of the robberies took place at Sav-on Liquors, 1414 14<sup>th</sup> Street. Masked men with guns entered and took cash and the store owner's wallet, including credit cards. The robbers used the credit card within an hour—without wearing masks—at a gas station with surveillance camera. Property crime including theft from auto was down 20%. Commissioner Raymond asked Officer Caron about the rate of recovery of property stolen from autos. Officer Caron said it is both difficult to convict the perpetrator and that it is difficult for property owners to recover stolen property. She reminded everyone to note the serial numbers and other identifying features before property is taken.

Sergeant-Kim Allen introduced himself to the ANC community meeting and stated he is new to MPD Third District. # 15<sup>th</sup> Street NW Reconfiguration Analysis

Since the summer of 2007, DDOT has been reviewing access, safety and speeding along 15th Street, NW between Massachusetts Avenue and Florida Avenue. DDOT presented four alternative configurations for public comment and analyzed them on the basis of bicycle level of service, vehicle level of service, cost, and timing. DDOT accepted public comments via mail and email and on June 19, 2008 presented the analysis in a public meeting at the 15th Street Presbyterian Church. At the meeting, attendees were asked to rank each of the four alternatives and the existing condition of 4 northbound lanes 1-5 (one being the most preferred 5 the least). Based upon these ratings, participant comments, and the numerous e-mail received, there was no clear outcome.

Due to the lack of a clear consensus, DDOT developed a fifth alternative as a compromise between the desire to maintain one-way traffic and the desire for more bicycle facilities. This hybrid alternative features three northbound travel lanes, and bicycle lanes in both directions. Next, the existing conditions and five alternatives were evaluated using 11 criteria that reflect the objectives stated in the June 2008 "15th St, NW Reconfiguration Alternatives and Analysis" report and the comments from the public meeting and emails. Callers must identify the location including the correct quadrant (NW, SW, NE, and SE) in the city and as much detail as possible about the hazard, including the approximate size and depth of the pothole. (DDOT crews will also be out on the streets seeking to locate potholes. DDOT repairs an average of 220,000 potholes per year at an average annual cost of \$900K.

# **Community Development Committee**

1332 Vermont Avenue- Renovation and small addition to the ground level and first floor. At the request of the owners of the property, this matter was removed from the agenda for the meeting.

1329 R Street- Renovation and addition- seeking special exemptions before the Board of Zoning Adjustments (BZA) -Hayes Nuss, Owner, appeared before the CDC which reported to the

meeting that the front of the existing house is three floor (plus basement), and the back is two floors (plus basement) with an open court to the east. The proposed addition will occupy a portion of the existing court; add a third floor to the back of the house and a roof structure to accommodate elevator and stair access to the roof for a roof deck. The finished house will be consistently three floors, front-to-back, with a closed-court and roof structure.

The three special exceptions requested are:

- 1. Relief for the setback requirements of roof structures- the roof structure is required to be set back from the exterior wall a distance equal to the height of the roof structure.
- 2. Relief from court requirement because the property has an existing open court that, due to its dimensions, is nonconforming. In closing the court, the owner will convert the existing open court into a nonconforming closed court.
- 3. Relief for lot occupancy to increase the lot occupancy from 58.4% to 66.5% to change an existing non-conforming open court into a new non-conforming closed court, and to locate the roof structure within the required setback from the closed court.

All neighbors have been notified either in person or by mail. BZA hearing date is set for March 24, 2009.

The CDC unanimously recommended advising the BZA to approve all requested exceptions, the Committee having determined that the applicant had demonstrated compliance with the statutory criteria for the grant of such exceptions.

**RESOLVED**, That, ANC2F advise the Board of Zoning Adjustments to grant the above three special exceptions, having demonstrated compliance with the statutory criteria for such exceptions.

901 K Street Public Space commercial office building-bollards

An application pending with the Department of Transportation for a public space permit to construct bollards at 901K Street was presented to the meeting. The location of the space is in a business district, and not within any historic district.

Appeal of BZA Ruling with Respect to Morrison-Clark

Chairman **Reed** reported that the Quincy Park Condominium has noted an appeal to the Board of Zoning Adjustments ruling denying a rehearing of the application of owners of the Morrison Clark Hotel (11th and H Streets, NW) for special exceptions and variances and granting the requested exceptions and variances. In addition, counsel for the Condominium has requested that ANC2F file an *amicus* brief supporting the position of the Condominium. Noting that this Commission had also advised the BZA to grant a full rehearing, and that the BZA denied such advice, Reed recommended that this Commission accede to the request to file an amicus brief.
