ADVISORY NEIGHBORHOOD COMMISSION 2F REGULAR MONTHLY PUBLIC MEETING

Chairman Reed called the meeting to order at 7:00 p.m. He noted that a quorum was present and that the meeting had been duly noticed, and he directed that a copy of the notice of the meeting be filed with the minutes.

COMMUNITY FORUM

Commissioner Announcements and Monthly Government Reports

Commissioner Raymond announced that The Department of Public Works (DPW) has announced that daytime mechanical street sweeping will resume in scheduled, signed residential neighborhoods on Monday, March 22, 2010. Alternate-side parking restrictions in these areas will go into effect as well. Parking tickets, which carry a \$30 fine, will be issued, beginning March 29, to vehicles parked during street sweeping hours in areas posted with "No Parking/Street Cleaning" signs.

Chairman Reed attended the Quincy Park Condominium appeal.

Council Member Jack Evans

Evans discussion included District finances and the budget, as well as snow removal, two very popular topics across Ward 2.

"We've not increased the budget this year," Evans told residents. "But even when the budget is static, our expenses go up by \$500 million on things such as increases in pension plan payments, utilities, and cost of living." The Council will spend the next few weeks reviewing

the FY 09 and FY 10 budgets in anticipation of the FY 11 budget, which will be presented to the Council by the Mayor in early April.

Evans then went on to address questions about the snow removal efforts by the city. "The Mayor and I were out on trucks, riding through parts of Ward 2 to see what streets might have been missed, or need more attention," he said. "It was a very complicated process." He applauded ANC 2F's decision to appoint an ad-hoc committee to present a report of what worked, and what did not in Logan Circle, and encouraged them to make recommendations that will then be shared.

He also stated that the O Street Market is moving forward with a ground breaking quite possibly taking place in the fall of this year.

The Council's Committee on Public Works and Transportation has recently announced as part of its 2009-2010 Agency Performance Oversight Hearings, an opportunity for residents to testify on Bill 18-596, the "Winter Sidewalk Safety Amendment Act of 2009." Bill 18-596, introduced by Council members Cheh (Ward 3) and Wells (Ward 6), proposes to establish fines to enforce snow removal requirements and would require the Mayor to issue rules to implement this act. The proposed fine would be no less than \$25 for a person or entity who fails to remove snow and/or ice from sidewalks, and no less than \$250 for businesses.

Chairman Reed inquired about ANC2F applying for a National Endowment of the Arts grant (NEA) through the Office of Planning. The ANC would apply for NEA grant in support of the rebranding efforts of MidCity Business Association.

Chairman Reed referred to the fact that the ANC might wish to apply in its own name for a National Endowment of the Arts grant (NEA) which the Office of Planning brought to its attention and encouraged to seek. The ANC would use the funds to finance the "branding" effort endorsed by the ANC 2F Committee on the Arts Overlay Zoning (AOC). Reed pointed out, however, that DC law requires that the City Counsel act to approve such an application. The problem, Reed noted, was that such an act requires that Congress have 30 days review. This process would place the ANC out of time for the filing deadline. Evans indicated that the Council could invoke its emergency legislative powers which may avoid the delay. The NEA grant would be used to support the efforts of MidCity Business Association to "re-brand" our area, an effort supported by the recommendations of the AOC recently submitted to the DC Office of Planning.

<u>PSA 307 Report – Lt. Vanessa M</u>oore

Sergeant Bobeck announced that overall crime is down this month from this same month last year, with heavier declines in violent crime. He urged residents to remove all personal items from their cars as theft from autos continues to be a problem in the Logan Circle area. There has been an uptick in graffiti on 14th Street. Citizens should call if they see something suspicious. **Helen Kramer** asked why the two police officers parked at 12th and O Street why they did not respond to her request that they take action against a tour bus travelling on 12th street in violation of the well signed prohibition of bus use of that street in that vicinity. Bobeck indicated

that the two officers were on a stake out. In response to a question from **Andy Magil** about an aggressive panhandler in front of the 7-Eleven store at R.I. Avenue and 14th Street, Bobeck indicated that aggressive panhandling is illegal, and should be reported. Bobeck also liked the idea of using cell phone cameras to capture both incidents of aggressive panhandling and the identity of the panhandler.
