# 1201 13th St, NW – BZA variance requests

Deeley first moved that ANC 2F accept the CDC's recommendation for variance requests and be silent about the special exception request made by the applicant's attorney, Cary Kadlecek of Goulston & Storrs, at this meeting; the motion was seconded and approved unanimously by the

Commission.

1518 & 1520 Kingman PI, NW – HPRB concept, massing, and design

Deeley next moved that ANC 2F accept the CDC's recommendation for approval of the HPRB concept, massing, and design of the project, provided that any original historic doors are retained and any replaced doors are historically appropriate; the motion was seconded and approved unanimously by the Commission.
