#### Report from MPD PSA 307

Sqt. David Terestre

Sergeant David Terestre of PSA 307 shared the monthly crime report, which compared crime statistics between December 11, 2016 and January 11, 2017 to the same time period one year ago. Terestre noted that overall crime was down, but "theft from auto" is a persistent problem. Terestre shared a map of PSA 307 with community members and spoke to new MPD initiatives meant to create "new ways for the department to more effectively address crime in the District."

Sherri Kimbel, Director of Constituent Services for Coucilmember Jack Evans, provided four updates: 1) Residential Parking Permits will be enforced during Inauguration weekend; 2) trash collection will be limited due to Inauguration events and the MLK holiday; 3) Councilmember Evans will attend the February ANC 2F meeting; 4) there is a ribbon cutting on January 12 at the Compass Coffee in the Convention Center.

#### Report from Executive Office of the Mayor

Jerry Chapin, Ward 2 Liaison

Jerry Chapin, Ward 2 Liaison for the Mayor's Office, provided six updates: 1) the city will pick up Christmas trees through January 27; 2) 5,000 national guardsmen and 3,000 additional MPD officers will be deployed in D.C. during Inauguration weekend; 3) four permits have been issued for marches during Inauguration weekend; 4) use 311 to report issues to D.C. agencies; 5) the new Homeless Shelter Hotline is 202-399-7093; 6) congratulations to the Commissioners on their election.

#### **ABRA Policy Committee**

John Fanning

December Committee Report

Commissioner Fanning presented the Committee report from the December APC meeting. Fanning first provided updates on ongoing Settlement Agreement discussions with Drafting Table (1529 14th St, NW), Noddle Dog (922 N St, NW Rear), and Chicken and Whiskey (1738 14th St, NW).

Fanning then moved for adoption of all three APC recommendations, including:

- Protest of the new Class "D" Restaurant license for Shake Shack at 1400 P St, NW (2F02);
- Protest of the Class "C" Tavern license renewal for Piassa Ethiopian Cuisine & Cafe at 1336 9th St, NW (2F06);
- Support of the stipulated Class "B" Retailer's (full service) license request for Union Kitchen at 1251 9th St, NW (2F06).

Fanning noted the protest recommendations were based on the effect of the establishment on peace, order, and quiet, including the noise and litter provisions; the effect of the establishment on real property values; and, the effect of the establishment upon residential parking needs and vehicular and pedestrian safety. Fanning's motion was seconded and approved by the Commission.

December Committee Report

Commissioner Deeley presented each of the Committee's recommendations individually.

HPRB concept/rear and roof addition at 1534 14th St, NW (2F02) Commissioner Deeley After sharing the Committee's discussion and recommendation, Commissioner Fanning moved that ANC 2F write a letter to HPO in support of the concept/rear and roof addition as presented by the Applicant to the CDC; the motion was seconded and approved unanimously by the Commission.

**Vote: 5-0 (unanimous; Sylvester not present)** 

HPRB concept, massing & design for sidewalk enclosure at 1440 14th St, NW/Shake Shack (2F02) After sharing the Committee's discussion and recommendation, Commissioner Fanning moved that ANC 2F write a letter to HPO in support of the concept, massing & design for the sidewalk enclosure as presented by the Applicant to the CDC, subject to four specific changes requested by the CDC: 1) pulling the sides of the enclosure in to align with the outside edges of the two storefront openings rather than intersecting with and partially obscuring the building's masonry piers; 2) pulling the outside face of the enclosure in an additional few feet; 3) revising the signage on the enclosure since the signs as presented are not consistent with public space regulations; and 4) that the 14th Street side café be no wider than a two-top table. Fanning's motion was seconded and approved unanimously by the Commission.

#### **Resolution in support of Women's March on Washington**

Jill Ross

Jill Ross, community member and organizer for the Women's March on Washington, requested the Commission's support, in the form of a resolution, for the upcoming Women's March on Washington. Ross shared language from a similar resolution adopted by another ANC. Fanning read the resolution language and entertained edits from the Commission and community before moving for the resolution's adoption (see full resolution text at end of this document); the motion was seconded and approved by the Commission.

#### DCRA inspection of construction & illegal groundwater disposal at 1525 15th St, NW (2F02)

Commissioner Guggenmos detailed the history of the construction at the property in question, including past stop work orders issued by DCRA; neighbor complaints; evidence of improper disposal of groundwater into the city sewer system; and concerns about the environmental cleanup of the site (which was formerly a petrol station). Guggenmos moved that the Commission adopt a resolution requesting that DCRA inspect the property to ensure compliance with all required permits including the nonconforming PVC pipe; that DDOT inspect the property to ensure the discharge into to public space is not a nuisance; and that DOEE inspect the property in question to ensure proper mitigation and cleanup of the site given its use history, and in order to protect the health and wellbeing of all ANC 2F residents (see full resolution text at end of this document). Guggenmos' motion was seconded and approved unanimously by the Commission.

## A RESOLUTION OF ADVISORY NEIGHBORHOOD COMMISSION 2F The January 21, 2017 Women's March on Washington

WHEREAS, the rhetoric of the past election cycle has insulted, disparaged, and threatened many of us, WHEREAS, the Women's March on Washington (Women's March) stands for spirit of democracy and honoring the champions of human rights, dignity, and justice,

WHEREAS, ANC 2F ("the ANC") recognizes that the Women's March is a grassroots effort composed of dozens of independent coordinators,

WHEREAS, the ANC understands that the Women's March is a program featuring nationally recognized artists, entertainers, advocates, entrepreneurs, and thought leaders,

WHEREAS, to date, 145,000 Facebook users have indicated on the site that they would attend the march, and organizers indicated that they are planning to accommodate 200,000 people, and

WHEREAS, "people from across the nation will gather at the intersection of Independence Avenue and Third Street SW, near the U.S. Capitol, at 10:00am" on January 21st.

**THEREFORE, BE IT RESOLVED** that ANC 2F supports the Women's March on Washington and encourages participation by any of those who wish to participate in the demonstration.

**BE IT FURTHER RESOLVED** that ANC 2F supports the mission and principals of the Women's March as women's rights are human rights, regardless of a woman's race, ethnicity, religion, immigration status, sexual identity, gender expression, economic status, age, or disability.

**BE IT FURTHER RESOLVED** that ANC 2F condemns all hate speech and acts that seek to divide our community.

## A RESOLUTION OF ADVISORY NEIGHBORHOOD COMMISSION 2F Inspection of construction at 1525 15th St, NW (2F-02)

WHEREAS, over fifteen neighbors in 2F-02 have reached out to notify ANC 2F of potential construction violations at 1525 15th St, NW,

WHEREAS, the District Department of Consumer and Regulatory Affairs (DCRA) issued separate "stop work" orders for illegal construction without a permit on August 17, 2016 and August 19, 2016,

WHEREAS, the property in question was formerly used for commercial purposes as a gasoline filling station and the resulting environmental impacts on both the property and neighborhood are potentially significant,

WHEREAS, to date the construction permit holder still has not applied for a District of Columbia Water and Sewer Authority (WASA) permit for the disposal of construction and runoff water into the city's sewer system, and runoff water is presently being discharged on to a public space,

WHEREAS, the ANC 2F-02 Commissioner has made several unsuccessful attempts to obtain the owner's contact information and communicate with the owner.

**THEREFORE, BE IT RESOLVED** that ANC 2F requests that DCRA inspect the property in question to ensure compliance with all required permits including the nonconforming PVC pipe.

**BE IT FURTHER RESOLVED** that (DDOT) inspect the property in question to ensure the discharge into to public space is not a nuisance.

**BE IT FURTHER RESOLVED** that ANC 2F requests that the District Department of Energy & Environment (DOEE) inspect the property in question to ensure proper mitigation and cleanup of the site given its use history, and in order to protect the health and wellbeing of all ANC 2F residents.

This resolution was adopted unanimously (5-0) on January 11, 2017 by Advisory Neighborhood Commission 2F at a duly called and properly noticed public meeting with a quorum (at least four Commissioners) present and acting throughout.

# A RESOLUTION OF ADVISORY NEIGHBORHOOD COMMISSION 2F Approval of 2017 ANC Security Fund January 11, 2017
