## Report from MPD PSA 307

Sgt. David Terestre

Sergeant David Terestre shared the monthly crime report, which compared crime statistics between February 6, 2017 and March 8, 2017 to the same time period one year ago. Total crime, including property crime, is down. Community discussion followed about pervasive package theft in the neighborhood.

#### Report from Councilmember Jack Evans' office

## **ABRA Policy Committee**

Commodore at 1100 P St. NW (2F04)

Graham first moved for adoption of the Settlement Agreement negotiated between Commodore (at 1100 P St, NW) and the "Group of Five" neighbors; the motion was seconded and approved unanimously by the Commission.

#### Le Pain Quotidien at 1401 K St. NW

Graham next yielded the floor to Matt Menora of Mallis O'Brien, legal counsel for Le Pain Quotidien at 1401 K St, NW, who requested the Commission's support for a new Class "C" Restaurant license and summarized the application. Graham moved that the Commission send a letter to ABRA supporting the application; the motion was seconded and approved unanimously by the Commission.

February 22 committee meeting report

Graham first moved for adoption of all business items approved unanimously by the Committee at its February 22 meeting, including:

- Support for BZA special exceptions/penthouse requirements at 1411 K St, NW (2F05);
- Support for BZA variances for new construction at 1341 14th St, NW (2F03);

- Support for HPRB concept/two-story rear addition at 1454 ½ Q St, NW (2F02);
- Support for DDOT public space application for sidewalk cafe at 1010 Vermont Ave, NW/Chipotle (2F05):
- Support for BZA special exception/penthouse requirement at 930 P St, NW (2F06);
- Opposition to HPRB concept/new roof deck at 1336 9th St, NW (2F06).

The motion was seconded and approved unanimously by the Commission.

#### Resolution to request funding for express bus service on 14th St, NW

Graham

Graham introduced and moved to adopt a resolution to allocate \$1.2 million in funding for Bus 59, a new overlay metro bus line needed to supplement the Bus 50 service and reduce over-capacity congestion on the busy 14th Street, NW corridor (see full resolution as appendix); the motion was seconded and approved unanimously by the Commission.

Fanning introduced and moved to adopt a resolution to oppose the proposed Small Business Parking Permit Act of 2017 currently before the Council's consideration, noting that the issued RPP

## A RESOLUTION OF ADVISORY NEIGHBORHOOD COMMISSION 2F TO REQUEST FUNDING FOR ADDITIONAL EXPRESS BUS SERVICE ON 14TH STREET, NW

WHEREAS, The 14th Street, NW corridor has seen a significant amount of construction over the past ten years bringing new large apartment complexes, large and small condominium and cooperative buildings, government facilities and businesses, and

WHEREAS, It is the expressed goal of the Government of the District of Columbia to encourage and provide alternative means of transportation for the city's residents, visitors and suburban neighbors to include bicycle lanes, shared bicycle services and public transport, and

WHEREAS, The city's main public transportation system, Washington Metropolitan Area Transport Authority (WMATA) has met the growing population density and ridership demands on major north-south routes by adding express bus service along Georgia Avenue, NW & 16th Street, NW in 2007 and 2009, respectively, and

WHEREAS, WMATA and The District Department of Transportation (DDOT) conducted a comprehensive study in 2012 to examine the feasibility of implementing express bus service along 14th Street, NW Line, and

WHEREAS, The 14th Street, NW line was selected for study because about 15,000 passengers use the line on an average weekday, which is one of the highest levels of ridership in the Metrobus system, and

WHEREAS, The 14th Street Line has been identified as having reliability issues and related overcrowding problems over the conducted course of the study and subsequent years, and,

WHEREAS, WMATA will need funding from the District of Columbia government to implement express bus service along the 14th Street, NW Line, and,

WHEREAS, the Government of the District of Columbia contributed substantial financial assistance to WMATA for the initial operating cost for each of the aforementioned north-south express bus services along Georgia Avenue, NW and 16th Street, NW in the amount of \$1.2 million annually,

**THEREFORE BE IT RESOLVED** that Advisory Neighborhood Commission 2F requests that the Government of the District of Columbia fund the initial operating cost of an express bus service for the 14th Street, NW Limited Stop Bus Line at an equal contribution (in current year's dollars), as it funded the Georgia Avenue, NW & 16th Street, NW Lines.

**BE IT FURTHER RESOLVED** that WMATA implement such express bus service on the 14th Street, NW corridor at the earliest possible date after said funding has been approved by the Government of the District of Columbia.

This resolution was unanimously (7-0) adopted on March 8, 2017 by Advisory Neighborhood Commission 2F at a duly called and properly noticed public meeting with a quorum (at least five Commissioners) present and acting throughout.

## A RESOLUTION OF ADVISORY NEIGHBORHOOD COMMISSION 2F OPPOSING THE SMALL BUSINESS PARKING PERMIT ACT OF 2017 (B22-0125)

WHEREAS, Councilmembers R. White, Todd, and Nadeau introduced B22-0125 - the "Small Business Parking Permit Act of 2017" on February 21, 2017;

WHEREAS, Bill 22-0125 proposes to extend participation in the District's Residential Parking Permit program to small businesses with 10 employees or less that abut a street currently designated for residential permit parking;

WHEREAS, ANC 2F residents that reside on the 1300 and 1400 blocks from M Street to S Streets, NW would be directly impacted.

WHEREAS, Every employee of a qualifying business would be eligible to participate in the program and receive a parking pass;

WHEREAS, Small Business Parking Passes would be issued at the same fee as residential parking passes, a fee that is currently set at \$35;

WHEREAS, The Bill as introduced incentivizes Small Business Parking Program participants to drive to work rather than use public transportation due to the low cost of the permits, which is contrary to the District's goals to reduce reliance on automobiles;

WHEREAS, Advisory Neighborhood Commission 2F recognizes the need to find balanced ways to support both small businesses and District residents, especially with long-term use and access to a declining resource such as parking on public streets; and,

WHEREAS, The proposed legislation fails to address:

- 1) the already high demand for parking on public residential streets that currently exists in Ward 2:
- 2) how small business parking permits would be managed within the context of Ward 2's enhanced RPP program; and,
- 3) if small businesses would be permitted to participate in the RPP program if they are located in new buildings where residents have been denied participating in the RPP program through restrictive covenants.

**THEREFORE BE IT RESOLVED** that Advisory Neighborhood Commission 2F opposes B22-0125, the Small Business Parking Permit Act of 2017. The Commission appreciates the effort to support small and local business in the District of Columbia but finds the bill as introduced to be poorly thought out, lacking an equitable balance for both businesses and residents, and one that promotes a greater overall reliance on automobiles.
