# 1426 L St, NW (2F05)

DDOT public space application for sidewalk café

## Garrison Elementary School at 1200 S St, NW (2F01)

DDOT public space application for signage

Garrett Pressick, representative for the applicant, requested the Committee's support for a DDOT public space application that would permit construction of a sign and a bench for Garrison

# The Bird at 1337 11th St, NW (2F04)

David Winer, EatWell DC

BZA special exception for installation of retractable awning

David Winer, applicant, requested the Committee's support for the following two special exceptions and one variance required by the Office of Zoning to permit construction of a retractable awning on the rear side of the second story of the restaurant The Bird:

- a special exception to allow construction of a first floor one-story rear addition for an existing nonconforming structure;
- a special exception to allow a one-story first floor rear addition that does not comply with rear yard requirements;
- a variance to allow a one-story first floor rear addition that does not comply with the floor area ratio (FAR) requirements

The Committee inquired about the nature of the awning and Winer's attainment of other city agency permits. One community member shared concerns about potential noise from the outside space.

Commissioner Deeley moved that the CDC recommend that ANC 2F send a letter to BZA recommending approval of the two aforementioned special exceptions and one variance; the motion was seconded and approved by the Committee.
