Community Forum

Report from Metropolitan Police Department PSA 307

Captain Augustine

Captain Augustine shared the monthly crime report, which compared crime statistics from June. Violent crime is down 33% and property crime is down by 24%. The PSA continues to have issues with prostitution (six arrests in the last month). The police will be providing outreach to prostitutes. Illegal fireworks were an issue over the 4th of July holiday but residents commended the police force on a job well done.

Report from Councilmember Jack Evans' office Sherri Kimbel, Constituent Services Director Sherri Kimbel shared four updates from Councilmember Evans' office: 1) Grant funding is available for trash compactors; 2) the Chancellor's parent cabinet is looking for volunteers; 3) resident's are encouraged to sign up for Councilmember Evans' newsletter s; 4) Ward 2 will be hosting several social events this summer, including Night at the Nats game on July 26, Shakespeare in August,

and Breakfast at the Building Museum in August.

Jerry Chapin, Ward 2 Liaison

Jerry Chapin shared three updates from the Mayor's office: 1) the Mayor's Back to Basics Initiative includes anti-graffiti efforts; 2) residents are encouraged to sign up for the Mayor's newsletter; 3) in response to Commissioner Guggenmos noting the increase in homelessness in Logan Circle park, Chapin encouraged residents to report homeless individuals to the Department of Health Services and the Department of Behavioral Health.

Commissioner Fanning moved to adopt the draft meeting agenda with one modification: addition of a New Business item to consider supporting the "Best in Shaw" dog show. The motion was seconded and approved unanimously by the Commission.

ABRA Policy Committee

Commissioner Fanning gave the June 21st APC report in Commissioner Graham's absence.

Benito's Place at 1437 11th St. NW

Fanning moved that ANC 2F protest the New Class "C" Restaurant license for Benito's Place pending successful negotiation of a Settlement Agreement with the Applicant; the motion was seconded and approved unanimously by the Commission.

Resolution to request creation of a new ABRA license class for beer gardens
Committee member Morgan Finkelstein Morgan shared that the APC had drafted a resolution for
the Commission's review, approval, and remittance to Chairman McDuffy. Fanning moved that ANC
2F adopt the APC's resolution and send it to Chairman McDuffy; the motion was seconded but
Fanning declined to call the question after Commissioner Deeley suggested the Commission
postpone its vote on this matter until after the pending ABRA license for Dacha Beer Garden has
been settled. Fanning postponed vote on the matter to the August meeting.

Commissioner Deeley, Chair

Commissioner Deeley presented the CDC's one recommendation from its June 24 meeting regarding 1312 13th St, NW.

1312 13th St, NW (2F04)

Deeley reported that the CDC did not think the proposed project design fit with the historical context (while noting the split 5-4 Committee vote) and recommended that the ANC send a letter to HPRB in opposition of the application. Numerous residents from the adjoining property, Solo Piazza, shared their opposition to the project due to the fact that the proposal calls for blocking the

Solo Piazza's at-risk windows. After much discussion about the at-risk windows, Deeley moved that ANC 2F send a letter to the HPRB opposing the project for the following reasons:

- Opposition to two design elements (floating windows and lack of horizontal relationship between neighboring buildings);
- The front façade design does not contribute to or reflect historic preservation;
- Opposition to reclassification of the building as non-historic;
- Opposition to the proposed massing at the rear and on top of the project.

The motion was seconded and approved by the Commission.
